In case a copy is not available in the field: Slavik took a trip to the Middle and Far East in 1961 to find a location for another import-export firm. Reportedly, unable to locate any funds, he returned to Vienna where he later became manager of the Vienna branch of the import-export firm of Beno Steiner and Company, Istanbul. According to paragraph 3 of reference A. you are already familiar with that firm.</p> <p>2.
