A LANGUAGE TEACHER. WHEN SLAVIK BEGAN ASKING KUCUKKURT PENETRATING

QUESTIONS AND GRADUALLY BEGAN PAYING HIM FOR INFO ON TURKEY, KUCUK-

KURT CONTACTED ASKING FOR AND OBTAINING A FINANCIAL LOAN IN

EXCHANGE FOR HIS COOPERATION. KUCUKKURT FAILED TO REPAY

LOAN AND NEVZAT AKTAS, CHIEF OF FOURTH BRANCH WHO HANDLING

CASE, BROKE RELATIONS WITH KUCUKKURT. BELIEVES KUCUKKURT

PROBABLY CONTINUED TO WORK FOR SLAVIK AND CLAIMS KUCUKKURT VISITED

VIENNA ON SLAVIK'S INVITATION AND RECEIVED OPERATIONAL TRAINING.

TICARET) WITH WHICH SLAVIK ASSOCIATED. YUSUFIAN, HOWEVER, HAD NO ACCESS TO SLAVIK'S OFFICE AND WAS UNABLE PROVIDE ANY POSITIVE EVIDENCE AGAINST SLAVIK. [] THEN RECONTACTED AND RECRUITED KUCUKKURT AND PROVIDED HIM WITH DOCUMENTATION TO ESTABLISH EMPLOYMENT AS CIVILIAN WITH TURKISH MILITARY. AS DIRECTED BY [] KUCUKKURT THEN TELEPHONED SLAVIK TO ADVISE HIM OF HIS EMPLOYMENT. CONVERSATION MONITORED BY [] SLAVIK BEGAN BRIEFING KUCUKKURT ON MILITARY REQUIREMENTS AND EVENTUALLY PAID HIM BETWEEN 300-500 LIRA PER REPORT SUBMITTED.

3. [] SURVEILLANCE ESTABLISHED THAT SLAVIK MADE FREQUENT TRIPS TO ANKARA WHERE HE CONTACTED TWO POLITICIANS AND MINISTRY OF COMMERCE OFFICIAL. [] ANXIOUS TO PRODUCE SUCCESSFUL OPS, DID NOT WAIT UNTIL ALL FACTS IN CASE UNCOVERED AND ARRANGED FOR SLAVIK'S ARREST IN BARIKAN HOTEL IN ANKARA WHEN KUCUKKURT PASSING REPORT. [] ISTANBUL INTERROGATION OF SLAVIK LASTED ONLY FOUR HOURS AND PRODUCED ONLY BASIC BIOGRAPHIC DATA. [] SEARCH OF SLAVIK'S OFFICE, HOWEVER, PRODUCED REPORTS AND RECEIPTS OF BOTH POLITICIANS AND MINISTRY OF COMMERCE OFFICIAL. MINISTRY OF COMMERCE,

WHEN REQUESTED BY MILITARY COURT TO ASSESS IMPORTANCE OF REPORTS, REPLIED THAT DOCUMENTS "NOT ENDANGERING NATIONAL SECURITY." BOTH POLITICIANS GAVE SLAVIK INFO ON INTERNAL DISSENTION AND PLANS OF THEIR RESPECTIVE PARTIES AND RESPONDED TO A QUESTIONNAIRE ON NATO WHICH WAS ALSO DISCOVERED IN SLAVIK'S OFFICE. MILITARY COURT HAS NO DOUBT THAT BOTH POLITICIANS GUILTY OF TREASON AND WILL BE SENTENCED.

4. ACCORDING TO [] [] (AS OF 20 FEB) HAD NO POSITIVE EVIDENCE THAT SLAVIK WORKED FOR SOVIETS.
