1. NOSTRIL SAW WRANGLE 26 NOV, THANKED FOR KIND ATTENTION GIVEN BROTHER AND COMPLIMENTED ON GOOD WORK HE DOING. NOSTRIL LATER SAW JORDINIAN VICE CONSUL BEIRUT MUHAMMAD BAGH WHO TOLD HIM WRANGLE SAID NOSTRIL TOO CLEVER, FOOLISH SEND HIM PBRIME AND GAVE NO REASON FOR ATTITUDE. BAGH SAID WRANGLE INTEL OFFICER 2 DEC WRANGLE PHONED NOSTRIL FOR VISIT. NOSTRIL RECEPTION UNFRIENDLY, ASKED ARE YOU WORKING FOR PBRIME MILITARY, WERE YOU PILOT IN WAR, ARE YOU CITIZEN, AND YOU SHOULD NOT SPEAK AGAINST ME, WHEN ASKED EXPLAIN, SAID YOU GUESS. NOSTRIL TOLD HIM NEVER SAID ANYTHING AGAINST HIM, HE WAS MISINFORMED AND LEFT.

2. NOSTRIL CLAIMS REFUGEES COMPLAINED HIGH COMMISSIONER GENEVA WRANGLE HANDLING OF OFFICE. WRANGLE HAS MADE SUBSTANTIAL FINANCIAL GAINS, WHEN VISITS JORDAN OFFICE SELDOM OPEN AND SPENDS TIME HUNTING.

3. RAFAT MUFTI BROTHER SAID MUFTI NOT GOOD TERMS NOSTRIL SINCE 1948 BECAUSE SUSPICIOUS RAFAT WIFE AND NOSTRIL TOO CLOSE. SAID MUFTI HAS IN PAST TAKEN NOSTRIL SIDE IN DISPUTES AND
