ALTHO [] HAS KNOWN WRANGEL FOR SOME TIME, IT WAS ONLY DURING CONVERSATION ON NOSTRIL ISSUE THAT WRANGEL REVEALED CONSIDERABLE AWARENESS OF KUBARK; IMPLIED LIAISON EXISTS BETWEEN TOLSTOY FOUNDATION AND KUBARK (ASSUME VIA []); ASSERTED "LIBERATION COMMITTEE" OF NEW YORK MUNICH RECEIVES SUBSIDY FROM ODACID KUBARK; AND INFERRED CONTACT BETWEEN FOUNDATION AND []
2. WRANGEL APPEARS INTELLIGENT, WELL EDUCATED, WELL MOTIVATED. CLAIMS WRITES OCCASIONAL REPORTS FOR AIR INTEL. SAID PREPARED COMPREHENSIVE REPORT ON CIRCASSIANS IN SYRIA JORDAN FOR ASCHAM WHICH HE FORWARDED VIA [] BEIRUT FACILITIES. (WOULD APPRECIATE COPY.)
