1. I WOULD APPRECIATE TRACES ON FOLLOWING SUBJECT:  
 ABD-AL-KARIM S O O B Z O K O V, POSSIBLY SOB0ZOKOV  
 AND IN ARABIC TRANSLITERATION OF CIRCASSIAN COMES OUT SWABSOKA.  
 SUBJECT IS CIRCASSIAN WHO WITH 200 OF HIS FOLLOWERS CAME TO JORDAN  
 IN 1947 AND REQUESTED ASYLUM FROM KING ABDULLAH. SUBJECT FOUGHT  
 WITH GERMANS AGAINST SOVIETS IN WW. II. IN 1948 CHARGE WAS MADE THAT  
 SUBJECT WAS SOVIET OR COMMUNIST AGENT. THIS CHARGE INVESTIGATED  
 BY JORDANIAN INTELLIGENCE, AT THAT TIME UNDER BRITISH OFFICER, AND  
 SUBJECT WAS CLEARED. SUBJECT IMMIGRATED TO U.S. IN 1955 AND NOW  
 LIVES AT 704 14TH AVENUE, PATTERSON, NEW JERSEY 07504.

2. SUBJECT WROTE LETTER TO C 1 REQUESTING GOOD CONDUCT  
 CERTIFICATE AND DOCUMENTS ATTESTING TO HIS CLEARANCE OF CHARGES  
 OF COMMUNIST INVOLVEMENT AS WELL AS ANY INDICATIONS HE EVER  
 INVOLVED IN WAR CRIMES DURING WWII. SUBJECT CLAIMS SOME  
 CIRCASSIANS NOW SPREADING STORIES THAT HE WAS MEMBER OF SS AND  
 KILLED JEWS, OTHER CIRCASSIANS, AND OTHER MINORITY MEMBERS
