1. On 12 February 1979, Assistant United States Attorney, Thomas H. Belote, from the office of the United States Attorney for the Southern District in New York, telephoned to confirm the 5 January letter which Mr. Mendelsohn sent to United States Attorney Fisk pointing out that the Special Litigation Unit will assume the responsibility and possible prosecution of Tscherim Soobzokov. A copy of this letter has already be provided to you. Belote has been introduced to our DCD focal point officer in New York, who has control of a set of sanitized Directorate files on Soobzokov. Mr. Belote was assured that he can have ready and reasonable access to this material at his direct request.

2. During this same conversation, Mr. Belote asked that two additional Assistant United States Attorneys in his office have their clearances certified for access to Agency material. In addition to the Soobzokov case, these individuals will be principally responsible for the investigation and possible prosecution of Andrija Artukovic.
