Dear Mr. Lynch,

Per your request of 30 January 1980 please find enclosed copies of the following documents and their English translation for your background use in the Soobzokov case:

A. Document dated 30 December 1942 which refers to Soobzokov as Chief of the Field Police and authorized him to search all villages in the area. (This document is in German. An English translation is enclosed.)

B. Document dated 14 November 1944 which refers to Soobzokov as a Military Commander. (This document is in Hungarian. An English translation is enclosed.)

These documents are for your background use only. The fact that they are in the possession of the CIA is classified information. These documents and information derived there from may not be used in any litigation without prior written approval from this Office. After these documents have served the purposes for which they were forwarded, they are to be returned to CIA for permanent retention. No duplication of the material without appropriate classification protection is permitted without prior approval of CIA.


