3. AVLOS SHOWS 83-OPT-NOV80. SPAKLER WAS BORN IN ERFURT, GERMANY, GREY UP IN BERLIN, ATTENDED UNIVERSITY IN BERLIN, MUNICH, LIPZIG AND MARBURG. HE BECAME A FULL LAWYER AND PRACTICED LAW UNTIL 1937. IN JANUARY 1938, HE WAS SENT AS ATTACHE FOR SOCIAL AND ECONOMIC QUESTIONS TO THE GERMAN EMBASSY IN ROME, WHERE HE SERVED UNTIL SEPTEMBER 8, 1943. HE RETURNED TO BERLIN TO WORK IN THE MINISTRY OF FOREIGN AFFAIRS AS FIRST COUNSELLOR IN THE FOREIGN COMMERCE DEPARTMENT. FOLLOWING THE END OF THE WAR, HE LEFT GOVERNMENT SERVICE AND RETURNED TO ROME TO WORK AT LEO INDUSTRIA CHEMICAL AND PHARMACEUTICAL COMPANY. HE MOVED TO MILAN IN 1960 AND HAS RESIDED IN OUR CONSULAR DISTRICT SINCE THEN. MR SPAKLER STATES HE HAS RECEIVED SEVERAL INDEFINITE VALIDITY B-1/B-2 VISAS FOR THE US, BEGINNING IN ROME IN 1956. A CHECK WITH ROME REVEALS NO FILE ON SPAKLER. SPAKLER HAS RECENTLY LOST HIS FRG PASSPORT CONTAINING HIS MOST RECENT VISA, WHICH HE SAID WAS ISSUED IN MILAN, BUT WE HAVE NO RECORD OF HIM.
