1 August 1940 till 4 July 1941 served as Lieutenant in the Baltic Territorial Corps organized by the Soviets. 4 July 1941 he deserted from this Corp.

April 1943 joined the Latvian Legion and served as Lieutenant in the Artillery regiment of the 15th Division. Fought with the Soviets at Nowo-Sokolniki, Welikaja, Opocka, in Kurland. 2 May 1945, after being transferred to Germany, was taken POW by the British near Lübeck. August 1945 was sent to a POW camp in Belgium. 16 March 1946 was discharged from the POW Camp.

During the war Subject was decorated by the Germans with EK 2nd Class, KVK 3rd Class and Badge for Wounded.
