1. ACCORDING TO ODENVY REPORT DATED 1942, SUBJ REF (S) WAS PAYOFF MAN FOR A KNOWN GERMAN AGENT WHILE SERVING AS FIRST SECRETARY OF GERMAN EMBASSY WASHINGTON.

2. ODACID REPORT DATED 1945 STATES THAT A FORMER COLLEAGUE OF S DESCRIBED HIM AS HONORARY MEMBER GERMAN SS DURING WWII.

3. REPORT FROM LISB DATED 1944 DESCRIBES S AS ASSIGNED TO AMERICAN SECTION OF FOREIGN PRESS, MINISTRY OF FOREIGN AFFAIRS, LISBON. S DESCRIBED AS EXPERT ON US POLITICAL AFFAIRS AND AS PROPAGANDIST.

4. KUBARKER DESCRIBED S IN 1948 AS NATIONALISTIC GERMAN WHO ANTI COMMUNIST AND ANTI-SOVIET WHOSE DENAZIFICATION COMPLETED. DURING THIS TIME S CONSIDERED FOR USE BY KUBARK AGAINST SOV TARGET IN GERMANY, BUT S DROPPED AS HIS CASE CONSIDERED "TOO MARGINAL".
