1. We are unable to offer an explanation for the arrival of the letter at the [redacted] address that was forwarded as Attachment I to the Reference. To our knowledge, the [redacted] address was used exclusively for the receipt of operational mail from AECOB/7. The letter that was forwarded for mailing to FCB by BFW-2232, 2 July 1956, was for AECOB/7 even though it was not so stated in the dispatch.

2. Since it has been quite definitely established that AECOB/7 is controlled by the HEB and the last communication was received from him in the late spring of 1958, it is not anticipated that future communications will be arriving from him. Despite this, it is suggested that you have AEMARSH/1 advise [redacted] that, while the receipt of mail is not anticipated, should she receive any, she should handle them as she did previously, i.e., forward them to AEMARSH/1.

3. The letter that was forwarded as Attachment I to the Reference was tested for the recovery of S/W with negative results. A formal handwriting analysis of this letter was not initiated since it did not appear to merit the expenditure of time and money required in such an analysis. However, an examination of the handwriting on each of the communications indicates that each was probably written by a different individual.
