Subject is unauthorized movement of JEWS from HUNGARY

1. ACC, HUNGARY, reports that Prime Minister of Hungary has previously been notified that transfer of any Jewish children is a direct violation of standing agreement and has requested the Prime Minister to take steps to stop further transfer of JEWISH children to GERMANY.

2. Reports from a usually reliable source received here indicate that certain local BUDAPEST organizations, aided by an AMERICAN organization, are planning the movement of JEWISH persons, including many children, to the US zone of Germany. In view of the situation per paragraph one above and this information, request that you endeavor to secure positive proof of any such movements from HUNGARY which have taken place since January 1946 in order that further action may be taken by ACC through official channels.

3. It is believed that presentation of such proof to ACC, HUNGARY, will tend to eliminate at least a substantial part of the present problem of infiltrates from that area.

4. Request that this HQ be informed of action taken and of any positive information of definite movements.

REFERENCE: SUBJECT UNAUTHORIZED MOVEMENT OF JEWS FROM  
HUNGARY

1. Estimate between 1 January and 1 April 8405 JEWISH infiltrees arrived US Sector Vienna. Estimate 2700 Hungarian nationality. Reports here indicate majority travel by rail from Budapest and Bratislava.

2. American and Hungarian organization cited in Para 2 not identified and Viennese agents if any unknown here.

3. Requests made to Soviet headquarters here have materially reduced influx of all refugees from Hungary since 1 April.

4. Pursuant to instructions in WARK 81553 refuge must be furnished persecuted persons who arrive in USFA area.
