CE T-1 advised on November 23, 1970, that LASZLO TARNOI is presently employed at Barber-Scotia College, West Cabarrus Avenue, Concord, North Carolina, as a Professor of Social Sciences. CE T-1 advised that TARNOI resides in the Harmony House Apartments, Park Drive, Concord, North Carolina, and lists his mailing address as follows:

CE T-1 further advised that TARNOI is a new member of the faculty at Barber-Scotia College. TARNOI reportedly does a lot of writing and had recently submitted an article for the Fall Edition of The Hourglass, a Quarterly Journal of Ecumenics of Today and Tomorrow. The article written by TARNOI was entitled "The Myth of a Mortal God (a Fantasy of the New 'Reality')." "

CE T-1 advised that TARNOI is well thought of by the students and has not been involved in any irregular activities of any kind on the college campus.

CE T-1 advised on March 31, 1971, that TARNOI still maintains the same address and employment, and no information has been received concerning any irregular activities of any kind.

A source familiar with the activities of the New Left and Communist Party in the State of North Carolina has not reported TARNOI as a member of or participating in the activities of any of the above mentioned groups.

Mrs. VICTORIA MAIDEN, Clerk, District Records Section, Immigration and Naturalization Service (INS), Philadelphia, Pennsylvania, advised on March 2, 1971, that LASZLO TARNOI'S file had been transferred to the Immigration and Naturalization Service, District Office, Norfolk, Virginia, on February 24, 1971, due to his change of residence to that area. TARNOI was still under voluntary departure status awaiting the availability of a visa quota number for change of status to permanent resident.
