2. ACCORDING TO ALIAS FLEMING UPHILL INTENDS TO INTERROGATE/ INTERVIEW ALL THE ABOVE IN EARLY JULY IN AN ATTEMPT TO CLARIFY THEIR SUSPICIONS OF GREIL, HOESSELBARTH AND, INDIRECTLY, UJDORYOT. ALIAS FLEMING WAS MOST RETICENT IN SAYING WHAT THE CURRENT STATUS OF THE ABOVE WAS BUT HE DID CONFIRM THAT FAYREL WORKED FOR UPHILL AND CAVATA AND THAT VON HANSTEIN WAS AN ACTIVE UPHILL 'MITARBEITER'. WE KNOW FROM OUR OWN TRACES THAT GLATHE AND SVOBODA ARE ACTIVE UPHILLERS AND THAT LANDIG ALLEGEDLY WAS NEVER HIRED BY UPHILL ALTHOUGH THEY WERE CONSIDERING IT IN 1951.
