1. WE DISCUSSED CASE WITH I&NS MAIN OFFICE AND THEY CABLED I&NS ROME ASKING STATUS AND ADVISING I&NS ROME THAT ADVERSE INFO AVAILABLE ON MARY SCHNEIDER. I&NS HERE WILL ALSO ACCEPT FROM US DETAILED QUESTIONS WHICH THEY PLAN ASK SCHNEIDER IN ROME AS PART OF PROCESSING FOR US IMMIGRATION.4

2. ACCORDING I&NS, SCHNEIDER APPLYING US ENTRY IN ROUTINE REFUGEE MANNER, I.E. AS A TWO-YEAR PAROLEE. SHE ALSO HAS SEPARATE REQUEST WITH STATE DEPARTMENT, HOWEVER, REGARDING POSSIBLE RECOGNITION HER PREVIOUS US CITIZENSHIP.4
