SEHMSDORF ACCOMPANIED BY WIFE ANTONIA NEE DVARANAUSKAS, BORN 2 OCT 90 IN VILKI/KOWNO, LITHUANIA, SON PETER SIGISMUND BORN 31 OCT 18 IN KOWNO, AND DAUGHETE SOPHIE BORN 15 MAY 20 IN RIETAVA/KROTTINGEN. DAUGHTER STASE KATHARINE BORN 6 JUNE 23 IN VILKI DID NOT ACCOMPANY. IN FEB 43 SEHMSDORF REQUESTED PERMISSION RETURN TO LITHUANIA.
