1. ERICH WOLLENBERG DIED ON 6 NOVEMBER 1973 HAMBURG HOSPITAL, THROUGH LANDLORD WALTER DIETZ IN LUEBECK DETERMINED THAT EXECUTOR OF ESTATE IS ULF ANDERSEN, BERNERCHAUSSE 76, HAMBURG.

2. IN DISCREET TELEPHONE CONVERSATION DETERMINED THAT ANDERSEN HAS ALL MANUSCRIPT MATERIAL, INCLUDING TAPES. MATERIALS ARE, HOWEVER, SCATTERED AND INCOMPLETE AND HAVE LITTLE COHESIVENESS. ANDERSEN IS WORKING ON THEM, HOPES TO PULL TOGETHER ENTIRE COLLECTION FOR PUBLICATION, SOUNDED COOPERATIVE AND PROMISED TO RESPOND LATER TO WRITTEN QUESTIONS RE HIS PROGRESS TOWARD COMPLETION MANUSCRIPT FOR PUBLICATION.
