Curriculum Vitae of Sven Gunnar Treuhoff

Sven Gunnar Treuhoff was born on 21 February 1922 in Tallinn, Estonia. His father had been an active officer in the Estonian Army and had participated in the Estonian War for Freedom in 1918; his father was killed accidentally by a dynamite explosion in 1935. He had one sister who was born in 1924 and who deceased in Estonia in 1928. His mother is living and is residing in Frankfurt Germany.

Mr. Treuhoff has never been a member of a political organization or party. He escaped to Germany from Estonia in March, 1941 with his mother in order to avoid conscription into the Soviet Army. In Germany he was enlisted into a Police Reserve Unit by Emergency Decree on 16 July 1941. On 23 December 1942 he was transferred to the "Estonian Legion" and later served on the Eastern Front against the Russian Army. He was wounded on 18 September 1943 and was sent to his home city of Tallinn, Estonia by the German authorities. In Tallinn he studied and completed his high school education on 20 December 1943. After his recovery he was sent to the SS Junkerschule Teelz in Germany and on 21 December 1944 was promoted to Untersturmfuehrer. The "Estonian Legion" was designated an "SS" unit and Mr. Treuhoff is listed on Berlin Documents Center records in the SS Officer's file. Mr. Treuhoff stoutly affirms the involuntary nature of his services for the Nazi regime.

1943	Dec. 1943 Completed High School education in Tallinn.
1943	1945 Military Service.
1945	Aug. 1949 Employed part time with Stadtbauamt, Ffm, Landkonservator Hesse, Prof. Schwarz Architect Firm, E. Scheffer Architect Firm, while attending the Darmstadt Institut of Technology. Studied architecture.
1949	1950 Employed IRO Resettlement Division, Land Hesse.
1950	1951 Employed World's YMCA-IWCA, Land Hesse as Field Supervisor.
