1. Reference correspondence outlined CABALETTA 2's present activities for CADRUG, outlined the possibility of the future utilization of CABALETTA 2 within CABARIC Project, and submitted FRQ's Part I and II on CABALETTA 2.

In compliance with German Mission Directive 50-10, dated 9 June 1953, we are forwarding under separate cover three copies (one copy to German Mission Finance and two to Home Office) of a written contract signed by CABALETTA 2 on 11 October 1951. It is requested that Home Office route one copy of the written contract to the Special Contracting and Allowances Staff, Personnel Office, Headquarters, as per Par. 3 b. of AFR No. 30-5.

3. An amendment to Par. 4 of the forwarded contract was approved by [ ] on 3 July 1952 for an increase in CABALETTA 2's salary to DM 400.00 per month to be effective as of 1 April 1952. CABALETTA 2's current salary is DM 400.00 per month.

## MEMORANDUM FOR RECORD.

NAME : Sven TREUHOFF

This is to confirm in writing the terms of the agreement under which I have been - and shall continue to be, until further notice - employed by you. This agreement supercedes all previous agreements written or oral:

1. I shall conduct for you certain activities and shall devote my time and energy to those activities to the exclusion of any other gainful employment, unless such additional employment is specifically authorized by you.
2. In the conduct of those activities, I shall be entirely guided by your directives and shall submit to you all required reports, financial statements and so forth.
3. I acknowledge that I have been pledged to secrecy concerning all aspects of this agreement and the work performed under its terms.
4. For the above services , I shall receive a monthly salary of 300 DM.
5. I shall receive no compensation for hospitalization or other medical expenses, not shall I receive any disability benefits nor shall my dependents receive any death benefits.
6. I shall accrue no annual or sick leave, but I shall be allowed sick leave and paid vacations as authorized by my employer so long as these absences do not interfere with the performance of my duties.
7. When my official duties require that I travel, I shall be reimbursed for transportation costs and other essential official expenditures.
8. In the event of damage to an official vehicle while being used by me, I shall submit a complete report so that it can be determined if I am to be held financially liable or if the damage occured while engaged in authorized duties and was not due to my negligence in which case I shall be reimbursed for repairs.
9. This agreement has been concluded for an indefinite time. It can be terminated by either party:
  - (a) By giving notice, one month prior to the desired date of termination.
  - (b) Without notice, in case of a major breach of the present agreement, notably in the case of a breach of secrecy (Art. 3 above ).
10. I acknowledge that the agreement cannot be terminated by me unless I have previously accounted for all funds, supplies and other assets which I may hold as a result of this employment and turned over all assets, material or intellectual, including all personnel, contacts and information, to whomever you may designate to receive them.
