ROMANIAN SECURITY OFFICIALS HAVE ADVISED THAT THEY CONSIDER THIS SUBJECT TO BE ANTI ROMANIAN AND FEEL THAT HE WILL TRAVEL TO ANY STOPS MADE BY ROMANIAN PRESIDENT. THEY CLAIM HE IS RESPONSIBLE FOR SEVERAL DEATHS IN ROMANIA, HAD AN EXTENSIVE CRIMINAL RECORD THERE AND WAS SENTENCED TO DEATH IN 1941.
