1. CIC states that Michael HOELLER, born 10 June 1920 in OEDENBURG who claims to be a CIC agent, has never been associated with them. They request traces and interest (past and present) in order to reply to a query re his possible agent status from the Heidelberg Criminal Police who have him in custody. They add that a similar situation involving Subject arose in the past (date unknown) and was passed to KUBARK. According to their records KUBARK replied that their agents would be instructed not to use CIC's name in this way.

Station files contain a possible trace dated 1952 on one Roland HUEBNER aka HOLEER, born 9 March 1920, place of birth unknown, last residence Berlin SW 68, Prinzessinenstr 28, who was dropped by KUBARK for security reasons in September 1952. We have no further information and no current interest. This inf may be passed to CIC

2. FYI: The BfV traced Subject in July 1955 on the occasion of a contact which he made with Amt Blank, claiming he had worked for CIC since 1949. This may be the instance referred to in reference. To this request we gave the information in paragraph 1 above. A trace of MOB files dated July 1955 revealed that Subject had been an UPSWING D/A since 1949 against the Katpol.
