1. REF MEANS BEFINAL WILL CONTINUE SEPARATE DIRTY DOCS COLLECTION FROM B 103. FOLLOWING COVERS CHANGE IN COMMO CHANNEL WHICH ARE NECESSARY DUE TO IMPENDING RESIGNATION

2. ANXIOUS TO SET UP KUBARK OR SMYOPIA CONTACT B 103 GROUP IN AUSTRIA SO USE OF [French] POUCH BE DISCONTINUED AFTER   RESIGNATION. UNDERSTAND AND SYMPATHIZE VIEN DESIRE NOT TO BECOME INVOLVED THIS GROUP (VIEN 2943 (IN 24257) BUT.

A. DOCS HIGHLY EVALUATED BY KUBARK AS WELL AS SMYOPIA CUSTOMERS

B. WHILE JOINT KUBARK/SMYOPIA OPS   MAY CONTINUE INDEFINITELY, DIRECT CONTACT WITH GROUP IN AUSTRIA WOULD HELP INSURE KUBARKS UNINTERRUPTED ACCESS THESE DOCS.

3. REQUEST AUSTRIAN STATION ATTEMPT PROVIDE CUTOFF OR LIVE DROP SALZ OR LINZ TO SERVICE TWO WAY COMMO BETWEEN BEFINAL IN

AND B 103 GROUP. DEAD DROP THEORETICALLY POSSIBLE BUT BELIEVE

THIS CLUMSY AND UNNECESSARY. NO NEED FOR STATION TO "RUN" OP, OR TO ACKNOWLEDGE OR ASSUME RESPONSIBILITY FOR B 103 VIS A VIS AUSTRIAN AUTHORITIES.

4. TO AVOID DIRECT CONTACT WITH B 103 GROUP SUGGEST [ ] , WHO IS [ ] REPRESENTATIVE INNSBRUCK, BE USED AS INTERMEDIARY. WOULD TRAVEL BIWEEKLY TO LINZ AND PICK UP DOCS FROM B 103 FOR DELIVERY TO CUTOUT OR LIVE DROP IN LINZ OR SALZ. COULD COME [ ] OCCASIONALLY TO DISCUSS ANY PROBLEMS WHICH COULD NOT BE HANDLED BY MAIL.

5. IF KUBARK UNABLE TO HANDLE ON THIS BASIS, SMYOPTIA WILL QUERY ITS STATION. [ ] WOULD THEN TRAVEL AUSTRIA WITH [ ] TO INTRODUCE [ ] TO SMYOPTIA STATION AND TO SETTLE DETAILS IN PERSON.

6. SMYOPTIA SUGGESTS JOINT DISSEM BEFINAL DOCS ANALYSES TO [French] TO OFFSET THEIR LOSS OF DIRECT ACCESS TO DOCS AND PREVENT THEIR ENTERING (PORTION GARBLED-BEING SERVICED). SEE PARA 3 [ ] 1227 (IN 20735).

7. RE PARA 3 VIEN 3215 (IN 35377). B 103 AND [ ] RESIDING LINZ, ACCORDING [ ] WHO SAW B 103 INNSBRUCK LATE AUG. WILL REQUEST EXACT ADDRESS IF NEEDED.

8. REQUEST VIEN ADVISE PARA 4 ABOVE. HQS PARAS 4 AND 6.
