1. Contact arrangements were provided for [ ] in last reference. Steps have been initiated to set up his covert training per your request. Traces requested will be forwarded in a separate dispatch.

2. It was noted in SIM-505, attached to first reference that some of [ ] representatives, such as Reverend Jozsef BAAN, probably identical with Jenő BAN of Enns, and Heinrich RATKI, a trusted associate of Bela LENGYEL, are known to have been engaged in intelligence work for other than US Services. [ ] should be warned to clear with KUBARK prior to appointing deputies of representatives who in turn may use that office for purposes contrary to that of KUBARK's. From the fact that [ ] requested traces in January 1953 on most of the personalities listed, it appears that [ ] intended to request clearances from us, but the case was not followed through at the Salzburg Base. We do not object to [ ] using Gen. Jozsef VASVARY and Col. Jenő KARSAY in the French Zone of Austria, because the French authorities would probably insist on personalities they favor. This is not the case, however, with BAAN and RATKI, whose contact with [ ] offices should be severed under some pretense which would protect [ ] his cover occupation and KUBARK.

3. You might have valid reasons for having [ ] cultivate Emil JUHASZ and to attempt to place Nora STEIN in the latter's office (see SIM-505). It would be appreciated if you would tell us about the reasons which prompted your action. We assume that you look upon Emil JUHASZ as a man who by virtue of his background and position could unwittingly play a key role in a CE-type operation if enemy interest in him continues. If this assumption is correct, it is not recommended that a contract agent and not a United States citizen as yet, be used to "cultivate" JUHASZ. In any event, a case of this nature which involves an American official requires closest coordination with VOB. [ ] should not become involved with this operation beyond furnishing such incidental leads as he might pick up through his own activities.
