1. [ ] REPORTED 20 APRIL THAT AMERICAN ATTORNEY SIMON J. NUSBAUM (OFFICES AT 301 EAST 47TH ST, NEW YORK; PHONE 371-8466) WAS RECEIVED BY NITRUST THAT DATE TO DISCUSS VERBELEN MATTER. AS [ ] UNDERSTOOD MATTER, NUSBAUM IS AN ATTORNEY IN PRIVATE PRACTICE WHO HAS BEEN COMMISSIONED BY DEPT OF JUSTICE TO INVESTIGATE VERBELEN CASE. [ ] ASKED WHETHER WE CAN DETERMINE THAT NUSBAUM IN FACT AN AUTHORIZED OFFICIAL IN JUSTICE'S INVESTIGATION. HE SPOKE OF HAVING BEEN IN VIENNA BEFOREHAND TO INTERVIEW AUSTRIAN AUTHORITIES.

2. [ ] DID NOT KNOW WHAT [ ] MIGHT HAVE SAID TO NUSBAUM BUT SAID [ ] TOOK IT UPON HIMSELF TO VOLUNTEER COS' NAME. (NUSBAUM DID NOT CONTACT COS AND WAS SCHEDULED RETURN NEW YORK 21 APRIL. UNKNOWN WHETHER HE WILL RETURN TO EUROPE.)
