2. SAMPLE HEADLINES:

- "THE AMERICANS 'DISCOVER' SS VERBELEN'S PAST" (INDEPENDENT LE SOIR - CIRC. 213,000);
- "FROM FLEMISH SS TO U.S. SERVICES" (CONSERVATIVE LA MEUSE/LA LANTERNE - CIRC. 133,000);
- "A BELGIAN WAR CRIMINAL, AMERICAN AGENT" (CONSERVATIVE CATHOLIC LA LIBRE BELGIQUE - CIRC. 90,000);
- "ROBERT VERBELEN SPIED FOR THE AMERICANS" (CONSERVATIVE LA DERNIERE HEURE - CIRC. 100,000);
- "'VERBELEN WAS A SPY FOR TEN YEARS IN AUSTRIA" (CATHOLIC HET BELANG VAN LIMBURG -CIRC. 98,000);
- "U.S. JUSTICE DEPARTMENT RELEASES REPORT: WAR CRIMINAL VERBELEN WAS U.S. SPY" (CONSERVATIVE CATHOLIC GAZET VAN ANTWERPEN -CIRC. 187,000).

3. CONSERVATIVE HET LAATSTE NIEUWS (CIRC. 304,000) CARRIED A FULL-PAGE REPORT ON THE CASE UNDER THE HEADING "AMERICANS ADMIT: ROBERT VERBELEN WORKED FOR CIA." THE PAPER WROTE THAT "THE PUBLICATION OF THE U.S. REPORT REOPENS ONE OF THE MOST PAINFUL WOUNDS FROM WORLD WAR II IN BELGIUM. A QUESTION HERE IS WHETHER THIS REOPENED 'VERBELEN CASE' CAN ESCALATE INTO A SECOND 'BARBIE CASE'" THE PAPER ALSO INTERVIEWED RELATIVES OF PEOPLE REPORTEDLY MURDERED BY VERBELEN AND HIS MEN DURING THE GERMAN OCCUPATION.

4. UNDER THE HEADING "LATE 'REVELATIONS' ABOUT VERBELEN", LIBERAL CATHOLIC DE STANDAARD (CIRC. 377,000) WROTE: "THE WIRE SERVICES COMPARE THE VERBELEN CASE WITH THAT OF KLAUS BARBIE....THEY RECALL THAT VERBELEN WAS SENTENCED TO DEATH IN ABSENTIA BY A BELGIAN MILITARY COURT FOR THE MURDER OF 101 PEOPLE AND THE TORTURING OF U.S. AIR FORCE PILOTS. THEY FORGET TO MENTION, HOWEVER, THAT VERBELEN APPEARED BEFORE AN AUSTRIAN COURT FOR ALL THESE CRIMES AND WAS ACQUITTED IN 1965. THE WIRE SERVICES ALSO FORGET THAT ALREADY IN 1984, A JEWISH ORGANIZATION CLAIMED VERBELEN TORTURED TWO U.S. PILOTS. GENE DINGLEDINE, ONE OF THE U.S. PILOTS WHO VISITED BELGIUM AT THAT TIME, TESTIFIED THEN THAT THEY WERE NEVER TORTURED BY VERBELEN. THE PUBLICATION OF THE REPORT TODAY, AT THE REQUEST OF THE B'NAI B'RITH, DOES NOT TAKE INTO ACCOUNT THESE TESTIMONIES, AND THEREFORE CREATES THE IMPRESSION OF BEING DESIGNED FOR ATMOSPHERICS RATHER THAN (TO ESTABLISH) THE HISTORICAL TRUTH."

5. INDEPENDENT LE SOIR (CIRC. 213,000) WROTE THAT THE DEPARTMENT OF JUSTICE'S ANNOUNCEMENT "CAUSED THE GREATEST SURPRISE IN BELGIUM WHERE THE USE OF VERBELEN BY THE U.S. INTELLIGENCE SERVICES HAS BEEN CONSIDERED AN ESTABLISHED FACT FOR SOME TEN YEARS....THE ACTIVITIES OF

THE FORMER MEMBERS OF THE BELGIAN SS FOR THE COUNTER-ESPIONAGE SERVICES OF THE U.S. ARMY ARE SHROUDED IN MYSTERY. VERBELEN, WHO PRESENTLY LIVES PEACEFULLY IN AUSTRIA...CLAIMED THAT IN 1955, WHEN AUSTRIA RECOVERED ITS INDEPENDENCE, HE SAVED IT FROM A COMMUNIST PLOT. WHAT DOES THAT MEAN? (HISTORIAN) ALBERT DE JONGHE WONDERS WHAT WAS THE USEFULNESS FOR THE AMERICANS OF A MAN WHO WAS PRIMARILY AND PROBABLY EXCLUSIVELY A BLOODTHIRSTY, ROUGHNECK SOLDIER, THE LEADER OF A MOB OF THUGS.
