REFERENCE(S)	<p>1. On 10 July 1959 [ ] requested the Station to furnish as much information as possible regarding the present activities of Dr. Léopold VOLLER, Austrian national, now residing at No. 10 Jägerstrasse, Salzburg.</p> <p>[ ] noted that the same request had been made to local SMOTH representatives.</p> <p>2. The request contained the following pertinent information:</p> <p>"It appears that VOLLER has been charged by the Austrian Security Service to penetrate the Fédération Internationale des Résistants (FIR). In order to accomplish his mission he is playing to some extent a 'double game' since it is known that he is furnishing varied information to the FIR as well as endeavoring to gain the confidence of deportees, 'resistants,' refugees, etc., who are hostile to the FIR. Such activity could constitute a grave danger to those anti-Communist contacts of VOLLER who are not aware of VOLLER's affiliations."</p> <p>3. The Station does not know the source of [ ] information. However, it is possible that it came from [ ] who was in contact with a Dr. VOLLER in Vienna during the summer of 1958, and may still have contact with him, or at least receive information concerning his activities.</p> <p>4. The Station would appreciate information concerning VOLLER's activities with instructions indicating the extent of the information that may be passed to [ ]</p> <p>5.
