On 21 March 1952, the files of the Einwohnermeldeamt (German Inhabitants Registration Office), ROTTACH (nca), Germany were examined and revealed the following information: SUBJECT was born 1 July 1896 in ROSTOCK (nca), GER, his full name is listed as Wilhelm VOSS. The listed occupation for SUBJECT is businessman (type of commodity not given). SUBJECT resided in ROTTACH from 1946 until sometime in 1951, at which time he traveled to CAIRO (nca), Egypt where he is presently residing. SUBJECT's address while living in ROTTACH was 116 Fuerstenastrasse. SUBJECT has a son Horst VOSS, born 5 November 1928 in HAVENSBRUECK (NSL/062), who is presently residing in ERLANGEN (NSL/031), Drauerickstrasse #7. SUBJECT also has a stepdaughter, Ursula DRAUDT, born HALEE on 24 September 1932 in MUNICH (M49/Y85), who is residing at #1107 Domänenstrasse, ROTTACH. Examination of a letter on file in the Einwohnermeldeamt revealed SUBJECT's address to be 7 Shara Usqandare Akbar, CAIRO, Heliopolis, Egypt.



On 24 March 1952, the files of the Passant (German Passport Office), 279 Landstrasse, MIESBACH (M48/201), Germany were examined and revealed no record of SUBJECT. The files did reveal that SUBJECT's wife, Helene Berta VOSS, born 9 September 1911 in BRESLAU (P52/Ch1), Germany received Passport #1375901 on 20 March 1951. (B-2)

AGENT'S NOTES: It is possible that SUBJECT went to Egypt illegally as he did not register out of his former community, and has no record at the MIESBACH Passant, from which SUBJECT should have received a passport to travel outside of Germany.
