ON WITH CIA IN THE PAST. AMBASSADOR HUNT PLANS TO MAKE A MAJOR FOREIGN POLICY SPEECH AT SEVERAL U.S UNIVERSITIES IN LATE NOVEMBER AND SHE WANTS TO BE PREPARED TO FIELD THE INEVITABLE QUESTION; "HAS WALDHEIM EVER COOPERATED WITH THE CIA IN THE PAST". THE DOJ'S FILE ON WALDHEIM. IF THERE IS NO INFORMATION AVAILABLE THAT IS SUITABLE FOR PASSAGE TO THE AMBASSADOR, WE WOULD APPRECIATE A READING OR STATEMENT ON OUR POLICY TOWARDS THESE TYPES OF ISSUES. THE AMBASSADOR WILL UNDOUBTEDLY ASK US FOR A REASON IF NO INFORMATION IS IS AVAILABLE. THANKS.
