USUN IS INSTRUCTED TO ASK FOR A COPY OF **KURT WALDHEIM** FILE (WHICH WE BELIEVE TO BE NUMBERED 79-724) ARCHIVED IN THE UN FOR USE BY THE USG IN DETERMINING THE VERACITY OF ALLEGATIONS CONCERNING WALDHEIM'S ACTIVITIES DURING WORLD WAR II. MISSION IS FURTHER REQUESTED TO ASK UN TO MAKE AVAILABLE TO THE USG ANY OTHER MATERIALS IN THE POSSESSION OF THE UN WHICH PERTAIN TO WALDHEIM'S ACTIVITIES DURING THE PERIOD OF 1933-1945. MISSION SHOULD ASSURE SECRETARIAT THAT FILE AND ANY OTHER MATERIALS PROVIDED WILL BE TREATED IN ACCORDANCE WITH THE STRICT RULES OF CONFIDENTIALITY GOVERNING THE HANDLING OF SUCH MATTERS.

3. PRESS GUIDANCE WILL BE FORTHCOMING ASAP.
