1. SWEDISH EMBASSY HAS RAISED WITH STATE DEPT ONCE AGAIN THE ISSUE OF RAUL WALLENBERG'S DISAPPEARANCE. QUESTIONS THIS TIME WERE PEGGED TO INFO SUMMARIZED IN MEMO TO STATE DTD 12 MARCH 74 (FORWARDED ()] PER REF B ON 15 MAY 74). THUS FAR, HQS CANNOT ADD TO INFO PROVIDED IN 1974 BUT WE ARE STILL CHECKING INFO ON WRANGEL ISLAND AND VICINITY TO DETERMINE WHETHER A PRISON CAMP IS OR WAS LOCATED THERE. CONGRESSIONAL INTEREST IN WRANGEL ISLAND HAS ALSO BEEN AROUSED BY ALLEGATIONS THAT U.S. ACTUALLY OWNS WRANGEL ISLAND, WHICH IS LOCATED CA. 160 MILES WEST OF ALASKA.

2. ABOVE IS PROVIDED FOR ()] INFO AND MAY BE USED IN DISCUSSION WITH LIAISON IN THE EVENT THAT THEY RAISE THE SUBJECT AGAIN. WE WILL ADVISE RESULTS OF CURRENT INVESTIGATION AS SOON AS THEY ARE IN.
