1. FOR [] INFORMATION AND POSSIBLE DISCUSSION WITH LIAISON, WE HAVE PROVIDED THE FOLLOWING STATEMENT TO THE STATE DEPT. FOR PASSAGE, IN CONFIDENCE, TO THE SWEDISH EMBASSY: "AVAILABLE EVIDENCE DOES NOT CONFIRM THE PRESENCE OF A PRISON CAMP ON WRANGEL ISLAND AT ANY TIME, AND LEADS US TO BELIEVE THAT NO SUCH CAMP EXISTED ON WRANGEL ISLAND IN 1960 OR LATER."

2. WITH REGARD TO FURTHER QUESTIONS CONCERNING THE HEARINGS HELD BY THE SENATE INTERNAL SECURITY COMMITTEE INVESTIGATING SOVIET LABOR CAMPS IN 1973, HQS ADVISED STATE DEPT. THAT WE CANNOT EVALUATE THE VERACITY OF OTHER INFORMATION GIVEN BY AVRAM SHIFRIN OR JEFRIM MISHINSKI (AKA "KOZLOV"). WE SUGGESTED THAT THE SWEDES QUERY THE ISRAELIS ABOUT THESE TWO MEN.

3. IN RESPONSE TO A FOLLOW-UP INQUIRY BY THE SWEDISH EMBASSY, HQS STATED THAT WE WOULD HAVE NO OBJECTION TO CONTACT BY THE SWEDES WITH TWO SOVIET EMIGRES (BORIS RABBOT AND MR. KMOXLOV) CURRENTLY RESIDING IN THE U.S., BUT THAT WE DO NOT KNOW THEIR EXACT ADDRESSES OR PHONE NUMBERS.
