SUBJECT: RAOUL WALLENBERG CASE

1. SECRET - ENTIRE TEXT.
2. ON AUGUST 30 MR. GUY VON DARDEL, BROTHER OF RAJUL WALLENBERG CALLED ON EUR/SDV DIRECTOR SHINN. MEETING WAS HELD AT VON DARDEL'S REQUEST.
3. VON DARDEL OPENED BY RECAPPING HIS RECENT LETTER TO DAS BARRY SEEKING USG ASSISTANCE IN CLARIFYING THE FATE OF HIS BROTHER. HE ASKED IF COMPUTER PRINTOUTS WERE AVAILABLE WITH NAMES OF SOVIET AND FOREIGN PRISONERS WHO HAD DIED IN THE SOVIET PRISON SYSTEM DURING AND AFTER WWII. SHINN EXPLAINED THAT REGRETFULLY THEY DO NOT EXIST. HOWEVER, HE SUGGESTED THAT IT MIGHT BE POSSIBLE TO INTERVIEW FORMER SOVIET DEFACTORS FROM THAT ERA, NOW LIVING IN THE US, TO OBTAIN INSIGHTS AT LEAST ON THE MODUS OPERANDI OF THOSE TIMES VIS A VIS WALLENBERG.
4. MEETING ENDED WITH SHINN ASSURING VON DAPDEL THAT DEPARTMENT WOULD MAKE EVERY EFFORT TO FOLLOW UP ON THIS
