PRESIDENT OF INTERPOL TO DISCUSS RAOUL  
WALLENBERG

TEXT:

1. ACTION REQUIRED: ADVISE RE POSSIBILITY OF RECEIVING CARL  
PERSSON IN APRIL.

2. ON 14 FEB, COS RECEIVED CARL G. ((PERSSON)) AT EMBASSY TO  
DISCUSS A REQUEST HE HAS TO MEET WITH SOMEONE FROM OUR AGENCY ABOUT  
RAOUL WALLENBERG. COS ACCDED TO THIS MEETING AS A COURTESY TO  
[ ] WHO IS PRESENTLY AN ADVISOR TO THE CURRENT SWEDISH  
POLICE COMMISSIONER AND A GOOD STATION CONTACT. PERSSON STATED THAT  
HE ENJOYED A GOOD RELATIONSHIP WITH THE STATION/EMBASSY WHEN HE WAS  
POLICE COMMISSIONER AND SINCE HIS RETIREMENT HE HAS BEEN WORKING  
WITH THE SWEDISH COMMISSION TO INVESTIGATE WALLENBERG'S  
DISAPPEARANCE/DEATH. PERSSON SAID THAT THE COMMISSION WAS COMING TO  
THE END OF THE ROAD ON ITS INVESTIGATION AND HAD RECEIVED CA 180  
DOCUMENTS FROM KGB FILES AND SPOKEN WITH MORE THAN A DOZEN FORMER  
KGB OFFICERS WHO HAD BEEN INVOLVED IN THE CASE. PERSSON SAID THAT  
HE WANTED VERY MUCH TO VISIT WASHINGTON AND SPEAK WITH SOMEONE IN  
OUR AGENCY KNOWLEDGEABLE ABOUT THE WALLENBERG CASE/KGB, PRIMARILY TO  
SEEK OUR ADVICE ABOUT WHAT STILL MIGHT BE DONE. HE REALIZES THAT  
TALKING WITH US MIGHT NOT TURN UP ANYTHING NEW BUT HE WANTS TO  
ASSURE HIMSELF THAT HE HAS EXHAUSTED ALL POSSIBLE AVENUES/APPROACHES  
AND THINKS WE MIGHT HAVE SOME HELPFUL INSIGHTS/SUGGESTIONS OR AT THE  
LEAST MAKE A GOOD SOUNDING BOARD FOR HIS THOUGHTS. HE SAID THAT HE

IS NOT SEEKING NEW DOCUMENTS ETC., BUT RATHER JUST SOMEONE TO TALK  
TO. AS AN ASIDE, HE NOTED THAT COOPERATION WITH THE CURRENT SVR

LEADERSHIP IS NOT OF THE SAME LEVEL AS IT HAD BEEN TWO OR THREE YEARS AGO AND COS SENSES A BIT OF FRUSTRATION ON PERSSON'S PART.

3. COS TOLD PERSSON THAT HE DID NOT KNOW IF ANYONE IN OUR ORGANIZATION WAS ACTIVELY STILL FOLLOWING THE CASE BUT DID PROMISE TO INQUIRE WHETHER THERE WAS ANYONE WHO COULD SIT DOWN AND SPEAK WITH HIM. HE SAID HE WOULD VERY MUCH LIKE TO TRAVEL TO THE U.S. ANYTIME IN APRIL, EXCEPT OVER EASTER. REALIZE THAT THIS IS PROBABLY NOT A BURNING ISSUE AT HQS, BUT IF THERE IS SOMEONE WHO IS KNOWLEDGEABLE ON THESE ISSUES WHO COULD SPARE A COUPLE OF HOURS, STATION, [ ] AND CURRENT POLICE COMMISSIONER WOULD BE APPRECIATIVE. PERSSON ADDED THAT HE IS INTIMATELY FAMILIAR WITH THE SWEDISH COMMISSION'S FINDINGS AND WOULD BE HAPPY TO SHARE WHAT HE KNOWS WITH WHOMEVER HE MEETS.
