SUBJECT: Request by Senator Carl Levin for
Declassification of Two CIA/Directorate
of Operations Documents Pertaining
to the Disappearance of Raoul Wallenberg

1. The following is in response to the General Counsel's inquiry regarding the justification of continuing to classify two documents (2 August 1956 and 16 October 1992) which pertain to the disappearance of Raoul Wallenberg. The request for declassification of these two documents was made by Senator Levin via a 12 December 1995 letter to the DCI.

2. Upon receipt of Senator Levin's request, the two documents in question were forwarded to the Information Review office of the Directorate of Operations (DO/IRO) to evaluate for possible declassification. DO/IRO determined that due to the operational information contained in these documents, the documents must remain classified pursuant to the National Security Act of 1947.

3. The 2 August 1956 document did not meet the criteria for declassification as it identifies the name of an asset of an operation unrelated to Wallenberg. In addition, this document contains the location of CIA/DO presence in Germany after 1955,

operational cryptonyms, names of covert CIA officers, as well as organizational file names.

4. The 16 October 1992 document did not meet declassification criteria as it contains information from a liaison service as well as comments by the Chief of a liaison service. This document also contains the location of CIA/DO presence, operational crypts, organizational titles/addressees, and a 201 file number.

5. Attached for your reference are the original versions of each document as well as the sanitized versions (copies of which Senator Levin submitted with his request). Please note: The sanitized versions (which are attached) contain the DO/IRO notations which outline specifically why the request for declassification of these two documents has been denied.

WALLENBERG PRIOR COB 6 NOVEMBER.

2. CHIEF OF BELGIAN SURETE, [] ASKED COS
ON 15 OCTOBER FOR ANY DATA ON CURRENT STATUS OF WALLENBERG, WHO
DISAPPEARED AT THE END OF WW II IN HUNGARY, AND WHO, ACCORDING
TO AUTHORITIES IN FORMER USSR AND CURRENT RUSSIA, IS DEAD.
WHILE [] HAD MENTIONED ISSUE IN PAST, APPARENTLY
FISHING. HE NEVER ACTUALLY ASKED FOR ANY INFORMATION. ON 15
OCTOBER, [] CAME BACK TO THE RAOUL WALLENBERG CASE. HE
SAID THAT THE HEAD OF THE WALLENBERG INTERNATIONAL COMMITTEE IS
A BELGIAN WOMAN WELL CONNECTED TO KING BANDAUM. FOR SOME TIME
BOTH SHE AND THE PALACE HAVE BEEN PRESSURING HIM TO DETERMINE
WALLENBERG'S CURRENT STATUS; I.E., DEAD OR ALIVE AND WHERE.
ISSUE HAS APPARENTLY BECOME ENOUGH OF A PROBLEM FOR HIM THAT HE
HAS COME TO US FOR HELP. AS HQS KNOWS FROM PREVIOUS TRAFFIC,
IT IS A DIFFICULT TIME IN HIS CAREER. HE WOULD PROBABLY
APPRECIATE THE CHANCE TO LOOK GOOD IN THE KING'S EYES. IF AT
ALL POSSIBLE, WE WOULD LIKE TO RESPOND IN A POSITIVE MANNER.
BECAUSE CHIEF/EUR IS SCHEDULED TO ARRIVE FOR A VISIT DURING
WHICH HE WILL BE HOSTED BY [] IT IS IMPORTANT THAT A
REPLY BE IN [] HANDS PRIOR TO CHIEF/EUR'S ARRIVAL.

3. [] SAID THAT HE HAD ACQUIRED, OR BEEN GIVEN, AN
OLD PHOTO WHICH HE HAD HAD ENLARGED OF, ALLEGEDLY, A SCENE IN A
SOVIET CONCENTRATION CAMP PURPORTING TO SHOW WALLENBERG. HE
HAD FOUND THE PHOTO INCONCLUSIVE. HE HAD ALSO ASKED HIS KGB
LIAISON LAST YEAR FOR ANY INFORMATION, A FRUITLESS EXERCISE.

WE MAY PASS TO HIM. A TEAR LINE WOULD BE PREFERABLE. HOWEVER,
WILL BE GLAD TO PASS IT ORALLY IF NEEDED. THANKS.
