1. Attached is a translation of an original police document giving extracts from Commercial Registry and police files covering the "Onstör-roichisches Kontor", a Karl von WINCKLER enterprise in Graz, and persons connected with it. The report was obtained from Graesper.

FIRM

2. Karl von WINCKLER is the principal figure in the CIC intelligence net Fort Worth and in the Austrian intelligence picture in general. The information should, therefore, probably be carded in Central Registry. The details of this report were not known to the CIC agents handling WINCKLER. is placing a copy in the D/G-2 file on Fort Worth.

Subject: State Police Investigation of "Oosterr.-Kontor" G.m.b.H.,
Graz, Opernring 15.

1. The firm "Oosterr.-Kontor" G.m.b.H. was founded on
13 November 1946 by the following persons:

2. On 17 January 1946, the firm was recorded as export-import
and transit firm in the Graz trade registry. The firm was founded
with the intention of interesting important foreign business circles
in trade with Austria and it was planned for certain foreign businessmen
who made credits available to the firm to become partners (Gesellschafter)
of the firm later on. The following foreign business agents are connected
with the firm:

Mr. John Caffery, Bern, a representative of Hambros Bank,
London. Mr. Caffery (or Mac Caffery) was formerly a British diplomat
and holds the rank of colonel in the British army. He is very interested
in the economic reconstruction of Austria and has already joined
the "Oosterr.-Kontor" as a partner.

Pedro Canellopoulo, Athens, partner in the Greek pyrite
concern Canellopoulo.

Julien Kraehling, a Paris lawyer and well-known figure
in the French Resistance.

Oxyda AG, a well-known Swiss trading firm.

3. The firm was registered on the strength of a license
held by Otto Kraft (see para 1, above) who at first took an active
part in running the firm. In view of his Nazi past, he was persuaded to
resign from the post of Geschaeftsfuehrer on 1 October 1946, and
Wolfgang Boesch, a director of Schwechater Breeu, took his place.
Kraft allegedly has no longer any influence on the firm, which operates,
however, still on the basis of Kraft's trade license.

4. As an additional partner, Walter Koenig joined the firm later on; he owns a lumber trading firm and sawing mill in St. Kathrein a. Lamning.

5. The following background information is submitted on the persons mentioned in the preceding paragraphs:

a. Dr. Karl von Winckler, born on 7 0 December 1912, businessman in Schlading, Dachsteinstrasse 140. He held a nazi party function in Schlading already prior to 1938.

b. Gertrude Winckler, born on 18 May 1917, wife of Karl Winckler, was a member of the NS-Frauensschaft 1936-38 and also a member of the ANST (Arbeitsgemeinschaft nationalsozialistischer Studenten). According to a statement by Karl Winckler, his wife was a member of the NSDAP.

c. Gertruda Winckler, daughter of the above Gertrude Winckler; birth date unknown. No record of nazi activity.

d. Dr. Otto Kraft, born on 26 August 1901, businessman residing in Graz, Koerblergasse 1 (office: Opernring 15); member of the NSDAP since 1931, of the SA since 1931, of the NSKK since 1938. On 18 December 1947 he was sentenced by a Vienna People's Court for violation of para 6 of the War Crimes Law, to one year in prison.

e. Dr. Franz Fichler, industrialist in Pruggern/Enns; further data unknown. He left the firm "Oesterr.-Kontor" some time ago.

f. Miss Herta Ekohl, born in Vienna, teacher, residing in Pruggern/Enns. She sold her share in the "Oesterr. Kontor". She joined the NSDAP in 1936 and held various party functions. In 1947 she was charged with violation of paras 8, 10 of the Denazification Law (Verbotsgesetz).

g. Dr. Erik Wintersberger, born on 10 September 1907, businessman, residing at Graz, Ruskertgasse 4. Police files contain no record of nazi activity on his part. He was however interned by the British in the Weissenstein camp from where he was released in March 1947.

- h. Hans ^Vessele (or Gesell), industrialist and vice-president of the Bundeswirtschaftskammer. No further information available.

- i. Wolfgang Boesch, director (Vorstandsmitglied) of the Schwechater Bräu, no further information available. Police files list one Wolfgang Boesch, born on 4 March 1896, residing in Graz, Elisabethnergasse 2, as former NSDAP member, but it is not definitely known whether this Boesch is identical with the Boesch associated with the "Oesterr. Kontor".

- j. Walter Koenig, born on 22 December 1889 in Berlin, Austrian citizen since 1949, residing at Graz, Grillparzerstrasse 27. Police files list him as a NSDAP member and holder of a 1938 Nazi decoration. Walter Koenig, then a German citizen, resided in Austria already prior to 1938. He left for Germany in 1936, but returned to Austria after the German occupation. In Austria he subsequently acquired a lumber trading firm and ~~sawmill~~ sawing mill in St. Kathrein a. Lamming which had been Jewish property. In 1946 the prosecutor at Graz preferred charges against him in this matter, but in a trial of the Graz People's Court in January 1949, he was acquitted.

6. No further information could be procured on the foreigners associated with the "Oesterr. Kontor".

7. Further investigation of the "Oesterr. Kontor" revealed that the firm transacted numerous foreign trade ~~maxx~~ deals recently and therefore does not appear to be a mere cover for other activities.
