4. REPORT OF FINDINGS

(DEVELOPED CHARACTER REFERENCE) On 6 July 1962, Mr. Walter Gauss, D-14 (Political Department), Stuttgart City Criminal Police, Stuttgart (NV 1303), GFR, was interviewed in his office regarding SUBJECT and stated substantially the following:

WIRSING is a respectable citizen of Stuttgart who was a member of the NSDAP (National-sozialistische Arbeiter Partei Deutschland) (Nationalist-Socialist Worker's Party of Germany) (Nazi Party) until 1945. SUBJECT discontinued his Nazi activities in 1945 and has been involved in no extremist activity, right or left, since that time. SUBJECT is connected with the "Bueru fuer Laender und Voelkerkunde" ("Office for Land and People Information"), Bismarckstrasse 30, Ludwigsburg (NV 1643), GFR, but the exact nature of HIS work there is unknown. HE is editor of the "Christ und Welt" ("Christ and The World") publication.

WIRSING is also involved in an unknown manner with various Arab countries (names unknown). HIS involvement stems from HIS having carried out missions on behalf of Germany in the near East in World War II. These involvements are not suspicious.

WIRSING possesses no Doctorate and should not be called "Doctor WIRSING." No further knowledge is possessed regarding WIRSING.

AGENT'S NOTES: Einwohnermeldeamt, (Residents Registration Office) checks in Stuttgart are ordinarily conducted for Intelligence Corps purposes through Criminal Police offices. Mr. Gauss made the above observations during the course of his seeing the Einwohnermeldeamt records to be examined regarding SUBJECT.
