1. DUE BOTH ZIPPER STAFF STATUS UJ-DREADFUL AND OBVIOUS FACT SECOND TEST OR MERELY INTERROGATION WOULD TIP OUR HAND TO ZIPPER AS WELL AS ALERT UJ-DREADFUL AND AUTOMATICALLY END ALL REALISTIC PROSPECTS SOLVING CASE, REINTERROGATION AND/OR CARRIAGE RE-RUN UNEFORTUNATELY IMPOSSIBLE AT THIS TIME.
2. SINCE BEST POSSIBLE POB STUDY UJ-DREADFUL PERSONAL BACKGROUND AND OPS RECORD CAN ONLY BE VIEWED AS INCONCLUSIVE, CARRIAGE RESULT WOULD BASIS CASE, WE DO NOT RELISH PROSPECT DISCUSSING WITH UTILITY UNLESS WE CAN DO SO WITH MAXIMUM CONFIDENCE IN CARRIAGE RESULTS. HOWEVER, SEE NO WAY AVOID CONFIDING UTILITY UNLESS REEXAMINATION CARRIAGE RECORD RESULTS IN REVERSED OPINION AND STATEMENT TEST UNRELIABLE OR INCONCLUSIVE.
3. BEFORE TAKING FURTHER ACTION POB WOULD APPRECIATE RECEIVING RESULTS MOST AUTHORITATIVE EVALUATION AND OFFICIAL POSITION ON UJ-DREADFUL CARRIAGE RESULTS SOONEST.
