1. STATUS UJDREADFUL CASE FOLLOWS.

2. PURSUANT FRAN 7909 (IN 47861) ( ) AND ( ) DISCUSSED CASE 30 OCT AND AGREED UTILITY BE FULLY INFORMED AND REQUESTED INVESTIGATE, KEEPING KNOWLEDGE ON MOST RESTRICTED BASIS. ALSO AGREED ULTIMATE INTERROGATION AND RE-CARRIAGE PROBABLY NECESSARY BUT LIKELIHOOD PROVING A CASE WHICH WOULD STAND UP IN COURT VERY SLIGHT.

3. ON 31 OCT ( ) AND ( ) BRIEFED UTILITY AND HERDAHL ON CIRCUMSTANCES LEADING TO CARRIAGE OF UJDREADFUL AND ON RESULTS. UTILITY STATED DUE HIS ABSENCE HE NOT CONSULTED, BUT WOULD HAVE DISAPPROVED IN PRINCIPLE CARRIAGE OF MEMBER HIS STAFF BY AIS OPERATOR. HOWEVER THIS POINT DROPPED IN VIEW RESULTS AND UTILITY READ GERMAN CARRIAGE REPORT ESPECIALLY PREPARED BY ( ) THIS CLEARED WITH ( ). UTILITY CLAIMED NO KNOWLEDGE UJDREADFUL HAD BEEN IN SOVIET HANDS, AND THAT EMPLOYMENT SUCH PERSONS IN HIGH ZIPPER STAFF POSITION AGAINST DIRECT UTILITY INSTRUCTIONS. UTILITY WAS BRIEFED ON POB VIEWS RE POSSIBLE CONDUCT AND DISPOSITION OF CASE IN TERMS ( ) ( ) DISCUSSION, AND WAS REQUESTED BEGIN CAREFUL INVESTIGATION UJDREADFUL BACKGROUND AND ALSO FORMULATE RECOMMENDATION ON HOW PROCEED.

4. UTILITY TURNED MATTER OVER FOR INVESTIGATIVE ACTION TO ALIAS SCHACK WHO PRODUCED TWO PAGE LEBENS LAUF DATED 1950 AS SOLE WRITTEN DATA ON UJDREADFUL. SCHACK PROPOSED HE CONFRONT UJDREADFUL DIRECTLY AND INTERROGATE WITHOUT ANY FURTHER PRIOR INVESTIGATION, PROVISION FOR DETENTION OR RE-CARRIAGE. POB TOOK EXCEPTION THESE PLANS AS LIKELY END IN WHITEWASH AND HARDLY CALCULATED CATCH POSSIBLE CLEVER SOVIET AGENT.

5. IN TALK WITH [ ] 25 NOV UTILITY STATED HE ASSUMED A IS SOLUTION TO CASE WOULD PROBABLY INVOLVE DIRECT INTERROGATION AND RE-CARRIAGE BUT THAT HIS PERSONAL INCLINATION FIRST TO ISOLATE WJ-DREADFUL AND HIS OPERATIONS FROM REST OF ZIPPER AND ARRANGE OBSERVE CAREFULLY OVER LIMITED PERIOD.

6. PENDING MORE FORMAL INVESTIGATIVE REPORT AND STATEMENT FROM UTILITY, POB OPEN MINDED ON MATTER. BECAUSE OF VIRTUAL IMPOSSIBILITY OBTAINING LEGAL PROOF FROM PURE INTERROGATION AND CARRIAGE AND IN VIEW DISPOSAL PROBLEM, OPERATIONAL ATTEMPT OBTAIN SUPPORTING EVIDENCE PROBABLY JUSTIFIED. HOWEVER, PROBABLY CHANCE SUCCESS OBVIOUSLY MOOT POINT.

7. REQUEST YOUR VIEWS. POUCHING COPY POB CASE FILES.
