1	801	829	23/9/54	<p>1. On 20 August @ HAMMER took up the UJDREADFUL Case again with [ ] He was concerned with the planned commitments of Dienststelle 5. Unfortunately, however, only part I of the three-part investigation/interrogation UJDREADFUL has thus far been completed. Since the most favorable time for the activation of the Dienststelle 5 commitments will take place about the 29<sup>th</sup> August when there is a full moon again he doubts seriously whether @ SCHACH will be able to have the investigation completed. As a matter of fact @ HAMMER believes it will be another 4 to 6 weeks before @ SCHACH's schedule can be fulfilled. [ ] reiterated our previous position, namely, that we did not wish to share responsibility in any commitments until the UJDREADFUL Case was completed. However, [ ] proposed the following as a possible solution provided [ ] will concur:</p> <ul style="list-style-type: none"><li>a. @ SCHACH to begin and complete Part II of the investigation which is the re-hash of UJDREADFUL's LOFLUTTER interrogation.</li><li>b. Since UJDREADFUL himself would by this time be quite aware that he was under definite suspicions he could be told that it was intended to go through with the current commitments on the presumption that UJDREADFUL would do nothing to compromise or betray them.</li><li>c. @ SCHACH would then immediately proceed with Part III of the investigation without the long delay in reducing the transcription of the interrogation to an @ SCHACH-treatment study.</li></ul> <p>2. [ ] stated that in fairness both to the members of Dienststelle 5, the American and German Hqs. Staffs who have also worked on these operations, as well as in fairness to UJDREADFUL himself, the case once started should be completed as soon as possible and not unnecessarily delayed and dragged out. @ HAMMER stated that he believed this would be a good compromise solution and he shared [ ]'s opinion that upon completion of Part II of the interrogation UJDREADFUL, even if sour, would hardly allow the commitments to fall of their purpose through any action on his part.</p>
