1. In accordance with reference A, Directorate of Operations STAR and Archives traces only were conducted on 272 persons who are of interest to the Department of Justice in its investigation of alleged Nazi war criminals. A "No Record" response was provided to IMS/FPLG on 137 of these individuals in DOR-00132 dated 23 May 1980. (C)

2. In a verbal conversation of 15 September between Deputy Chief, EIRS and [] IMS/FPLG, it was requested by [] that full DO traces, excluding DCB traces, now be conducted on the 135 remaining individuals. It was further agreed that only the official [] files of the individuals would be held in OG/EIRS for review and appropriate action by [] IMS/FPLG. All other documents pertaining to [] subjects would be reproduced and forwarded to FPLG. (C)

3. An intensive search of the files and indices of this Directorate has surfaced no record on the following subjects of reference A:
