ACTION REQUIRED - REFERENCES

REFERENCE: EGMA-67985, 27 January 1966 *28*

1. You may inform CATIDE that we have the following additional information on Subject;

a. A carded reference that may be identical to Subject lists one Fritz ZIETLOW as a Hauptsturmfuehrer with Amt VI (SD) RSHA Berlin in January 1943.

b. A KUTWIN card dated 19 April 1945 lists Subject as a Sipo/SD member in 1937.

c. HICOG information dated 1951 states that Subject was a Sipo/SD member in 1937; his address was Hamburg-Lensahl; he was promoted to SS-Hauptsturmfuehrer on 20 April 1939. He is an ex-Otto Strasser man and is a contact of Werner DIETZ, another ex-Strasser man. DIETZ is the Hamburg representative of Guenther GERKE, the founder of the Deutsche Soziale Partei which is trying to establish itself on the federal level. ZIETLOW is described as formerly of the Waffen-SS and of the foreign intelligence service of the SD, but presently a free lance contributor to several Hamburg newspapers. "ZIETLOW is trying to get in touch with all rightist groups; in the early summer of 1951 he was temporarily

a close collaborator of Beck-Breichsmitter, without tying himself to the Bruderschaft." He was a close friend of Dr. TAUBERT (© KOEL) who heads the anti-Communist "Bund fuer Freiheit" in Bonn. Their friendship probably extends from the period while TAUBERT was in the Nazi Propaganda Ministry in Berlin and ZIETLOW was a Nazi journalist in Berlin. ZIETLOW plans to publish a political information bulletin in collaboration with Walter STERNES, a member of the DSP.

d. A 17 November 1951 document, which may concern Subject, states that one Fritz ZIETLOW, Schriftleiter, Hamburg, was a participant of the meeting of German neutralists sponsored by the so-called Naueim circle on 17 - 18 March 1951.

e. EGQA-7893 dated 9 January 1953 forwarded to Pullach trace results, which probably were sent to CATIDE, to EGLA-1130. It mentioned that an R & A report dated 9 October 1950 listed individuals connected with the Strasser Movement. Fritz ZIETLOW of Rotenbaum Chausee 103, Hamburg, was to be Chief Editor of the party newspaper planned for early September 1950.

f. EGHA-2332 dated 22 September 1953 gave Subject's address as 182 Farmsener, Hamburg.

g. From 10 to 15 June 1956 one Fritz ZIETLOW, a newspaperman from Hamburg-Volksdorf, Germany, attended the International Meeting of Journalists in Helsinki.

2. The following is for your information only and may not be passed to CATIDE:

a. Subject's name appears in the Yugoslav "Black Book."

b. An ODENVY memo dated 7 October 1953 stated that Albert BOFMAN (201-15250), the Director of a one-man organization known as the United States Committee Against Militarism (USCAM), wrote to F. ZIETLOW, Hamburg-Lensahl, Olenreem 29, Germany.

NOTE: Albert BOFMAN © L. MORGAN, born 14 January 1913 in Chicago, resides at 913 West 69th Street, Chicago, Illinois. BOFMAN maintains a "peace library", writes and distributes peace propaganda, and receives publications from foreign countries including USSR and Red China. Since 1945 he has attended functions of numerous peace groups and Communist Party front groups. However, he is allegedly not a communist, but is an active and ardent supporter of the candidates of the Vegetarian Party. During WW II Albert BOFMAN was a conscientious objector and served 2 years for a violation of the Selective Service Act. In 1945 the Michael Reese Hospital diagnosed him as a schizophreniac.
