We note that according to the Central Registry trace forwarded as Attachment to Reference, Subject applied at the Consulate General in Stuttgart on 1 October 1964 for a US visa. Please arrange to examine the pertinent Consular file(s), and forward either a summary or, preferably, photostatic copies of the contents.

2. Your trace indicates that Subject registered into 15 Roentgenweg, Waiblingen, as of 13 October 1958; he has apparently not deregistered. We would like to establish the fact of his actual continued physical presence at that address, if at all possible. It is requested that a staff officer attempt to determine this, at least to the extent that his name is or is not on the mailbox. To our way of thinking, nothing more than walking past the house (or up and down the stairs of the apartment) is required.
