2. YOU ARE RIGHT THAT THIS MIGHT HAVE SOME UNSETTLING EFFECT ON ACKERMANN. HE BEEN WONDERING WHY IT TAKING FROM 14 OCTOBER FOR THE NOTES TO GET HERE. ALTHOUGH HE WILL OBVIOUSLY UNDERSTAND THE NECESSITY FOR SANITIZING THE NOTES, I THINK THAT HE WILL CONSIDER IT AN ERROR OF STYLE, AT LEAST, NOT TO HAVE PRO FORMA SOUGHT HIS AGREEMENT. I HOPE THAT FUTURE VISITORS WILL NOT SIMPLY HAND THEIR NOTES TO ALIAS DESSAU OR STICK THEM IN THEIR HIP POCKETS. ACKERMANN HAS BEEN WAITING FOR THE NOTES SINCE 2 NOV IN ORDER TO GIVE UTILITY A TWO-HOUR COMPLETE BRIEFING.
