1. WITH CONCURRENCE IN PRINCIPLE OF ALIAS MANTHEY, PROPOSE VISIT TO BKCROWN HEADQUARTERS FOR DISCUSSIONS FOR CIRCA THREE WORKING DAYS OF ALIAS FLEMING, CHIEF CASCOPE "FOREIGN SERVICES" BRANCH IN COLLECTION DIVISION, AND ALIAS KRUG, SENIOR CASE OFFICER UNDER FLEMING. SUGGEST PERIOD 27-29 NOVEMBER WITH 4-6 DECEMBER AS ALTERNATE. PROPOSE [ ] ACCOMPANY CASCOPE OFFICERS AS ESCORT OFFICER, AND REMAIN SEVERAL ADDITIONAL DAYS IN HEADQUARTERS FOR INDEPENDENT DISCUSSIONS AFTER CASCOPE OFFICERS LEAVE. REQUEST SPECIFIC APPROVAL FOR [ ] TO FLY LUFTHANSA WITH CASCOPE OFFICERS TO UNITED STATES, AND TAKE AMERICAN CARRIER ON RETURN TO MUNICH ALONE.

2. FLEMING SUGGESTS DISCUSSIONS BE AS INFORMAL AS POSSIBLE AND BE MORE AN EXCHANGE OF VIEWS THAT FORMAL BRIEFINGS. AMONG TOPICS HE WOULD LIKE TO TOUCH ARE THE FOLLOWING:
