1. IN ANTICIPATION OF ALIAS ACKERMANN'S FORTHCOMING VISIT TO HQS [] OFFERS THE FOLLOWING ADDITIONAL COMMENTS, PARTICULARLY WITH RESPECT TO HIS PRESENT AND PROBABLE FUTURE POSITION WITHIN CASCOPE.

2. ACKERMANN WAS ASSIGNED TO CASCOPE COLLECTION DIVISION BY CAUTOPIA PRIOR TO THE APPOINTMENT OF ALIAS MANTHEY AS CHIEF OF THE DIVISION IN MAY 1970. FOR NEARLY A YEAR THEREAFTER ALIAS STURM FUNCTIONED AS MANTHEY'S DEPUTY UNTIL HE WAS TRANSFERRED TO THE EVALUATION DIVISION. SINCE THAT TIME ACKERMANN HAS FUNCTIONED AS DEPUTY TO ALIAS MANTHEY AND ALSO AS CHIEF OF OPERATIONS. MANTHEY HAS COMMENTED TO [] THAT ACKERMANN REPRESENTS ONE OF THE FEW LONG-TIME CASCOPE OFFICERS WHO TOTALLY AGREES WITH HIS VIEWS ON HOW THE CASCOPE COLLECTION DIVISION SHOULD BE ORGANIZED AND RUN. MANTHEY HAS FOUND HIM TO BE AN EXCELLENT DEPUTY WHO FOLLOWS HIS OPERATIONAL AND ORGANIZATIONAL INSTRUCTIONS WITH GREAT ENERGY AND PERSEVERANCE.

MANTHEY COMMENTED FURTHER THAT ACKERMANN IS PROBABLY THE MOST EXPERIENCED AND COMPETENT OF ALL CASCOPE OPERATIONS PERSONNEL HE HAS MET AND INDICATED THAT ACKERMANN, IN THE PAST, RAN SOME OF THE MOST PRODUCTIVE AND HIGHEST-LEVEL CASCOPE OPERATIONS. WE HAVE LEARNED FROM ANOTHER SOURCE THAT ONE OF ACKERMANN'S CASES WAS KNOWN AS BRUTUS WHOM WE HAVE IDENTIFIED AS WALTER GRAMSCH (DPOB: 15 JAN 1897 IN BRESLAU) UNFORTUNATELY FILE ON THIS CASE HAS BEEN DESTROYED. REQUEST HQS PROVIDE DETAILS.

4. ACKERMANN IS A TIRELESS WORKER WHO SPENDS 10-12 HOURS AT ¹⁵91 DESK EVERY DAY. KNOW HIM WELL AS A PERSON. HE IS NOT INCLINED TO ACCEPT SOCIAL INVITATIONS. THIS WAS RECENTLY EXPLAINED, HOWEVER BY MANTHEY WHO STATED THAT MARITAL DIFFICULTIES HAVE RESULTED IN A SEPARATION BETWEEN ACKERMANN AND HIS WIFE WHICH HAS RESTRICTED HIS ABILITY TO ACCEPT SOCIAL INVITATIONS. BKROWN OFFICERS ^{WH} WHO HAVE KNOWN MANTHEY IN THE PAST WILL RECALL THAT A SIMILAR SITUATION OCCURRED SEVERAL YEARS AGO WHEN MANTHEY AND HIS WIFE WERE SEPARATED FOR A PERIOD OF TIME.

7. ACKERMANN IS POLITICALLY VERY CONSERVATIVE AND CAN BE CLASSIFIED AS A COLD WARRIOR TYPE. HE IS VERY SENSITIVE ABOUT HIS WAR-TIME ^RTRSHA BACKGROUND AND OVER-COMPENSATES FOR THIS BY BEING SOMEWHAT POMPOUS AND STANDOFFISH WITH HIS SUBORDINATES.

CASCOPE COLLEAGUES, INCLUDING ALIAS HARTWIG AND HIS WIFE, HAVE MADE NEGATIVE REMARKS ABOUT ACKERMANN AND HIS ARROGANT PERSONALITY. HOWEVER, NO ONE DENIES HIS INTELLIGENCE AND DEDICATION TO DUTY.

10. COMMENT: ACKERMANN'S CURRENT KEY ROLE IN THE COLLECTION DIVISION OF CASCOPE MAKES HIM ONE OF THE MORE IMPORTANT LIAISON PARTNERS [] OTHER CASCOPEERS WHOM WE KNOW BETTER SUCH AS MANTHEY, FLEMING AND BERNHARDT HAVE ENCOURAGED US TO IMPROVE OUR RELATIONS WITH ACKERMANN AND TO GIVE HIM THE BENEFIT OF OUR EXPERIENCE AND KNOWLEDGE. THEY ESTIMATE THAT THE FORTHCOMING VISIT TO HQS, IF PROPERLY DESIGNED TO IMPRESS UPON ACKERMANN OUR WILLINGNESS AND DESIRE TO ^{SHARC} ~~OPERATIONAL~~ OPERATIONAL EXPERIENCE WITH HIM, SHOULD GO A LONG WAY IN IMPROVING THE OVERALL COLLECTION EFFORTS OF CASCOPE AND AS WELL BENEFIT BKCROWN IN THE LONG RUN.
