1. DISCUSSED REF AGENDA WITH ALIASES ACKERMANN, KRUG, AND FLEMING MORNING 20 NOVEMBER. ACKERMANN AND OTHERS VERY PLEASED WITH PROPOSED AGENDA. ACKERMANN SUGGESTED ONLY ONE ADDITIONAL TOPIC IF TIME ALLOWS. HE WOULD APPRECIATE GENERAL UP-DATING ON MACHINE RECORDS WITH IDEN A, B, OR C. ANY OF WHOM HE WOULD ALSO LIKE TO SEE SOCIALLY. DURING LAST HQS VISIT IN 1966 ACKERMANN CONCENTRATED ON THIS SUBJ AND HE STILL MUCH INTERESTED.

2. I MENTIONED POSSIBILITY, ESPECIALLY ON 28 NOVEMBER, OF HAVING SEPARATE TALKS FOR ACKERMANN AND KRUG SO THAT ACKERMANN CAN DISCUSS TOPICS WHICH OF NO CONERN TO KRUG. ACKERMANN WELCOMED IDEA AS LONG AS HE HAS INTERPRETER BY HIS SIDE WHEN NEEDED.

3. ACKERMANN WOULD MUCH APPRECIATE BRIEFING ON CHINESE INTELLIGENCE SERVICE IF POSSIBLE.
