1. TRANSLATION OF REVISED CONTRACT HAS BEEN REVIEWED WITH SVDISH. ALTHOUGH SVDISH DOES NOT LIKE WORDING OF PARA 1.1.3 OF CONTRACT AND HAD REQUESTED WORDING CHANGE (CF. PARA 3A REF C), THEY ARE PREPARED TO LIVE WITH CASCOPE CONTRACT AS REVISED AS LONG AS CASCOPE AGREES AND UNDERSTANDS THAT FINAL DECISION ON MOVEMENT OF [] WITHIN U.S. WILL BE MADE BY SVDISH.

2. WELCOME VISIT BY ALIAS ACKERMANN ON 23 FEBRUARY TO OBTAIN LHMURRE SIGNATURE TO CONTRACT AMUNGST OTHER THINGS. WOULD APPRECIATE RECEIVING SOME OUTLINE OF HIS PLANNED SCHEDULE SO THAT WE CAN MAKE NECESSARY ARRANGEMENTS AND COORDINATE VARIOUS ASPECTS OF HIS VISIT. WE HOPE THAT HE WOULD HAVE TIME FOR MEETING WITH SVDISH ON 24 OR 25 FEBRUARY FOR BRIEF DISCUSSION OF LHMURRE AND QUESTION OF RESETTLEMENT OF LHMURRE MISTRESS. IN MEANTIME LOOK FORWARD TO LEARNING CASCOPE ANSWERS TO QUESTIONS POSED REF D.
