1. AS DISCUSSED WITH [ ] DURING HIS RECENT TDY, THE  
ACKERMANN VISIT IS NOW SCHEDULED FOR THE FIRST WEEK OF JUNE.  
ACCORDING TO ROSENLEHNER, ACKERMANN PLANS TO SPEND 2 AND 3 JUNE HERE  
AT HQS. WE PRESUME HE WILL ALSO SPEND SOME TIME WITH OTHER  
AGENCIES, BUT WE HAVE NO FIRM WORD ON THIS.

2. WE WOULD LIKE THE FOCUS OF HIS VISIT TO BE ON EAST  
EUROPEAN OPERATIONS, PARTICULARLY AGAINST MILITARY TARGETS.  
WE WANT TO DISCUSS WITH HIM WAYS TO IMPROVE COLLECTION AND  
EXPLOIT INFORMATION ON I&W IN SUPPORT OF NATO WAR PLANNING.  
THERE ARE, OF COURSE, OTHER TOPICS OF INTEREST WHICH HAVE BEEN  
NOTED IN REF AND RELATED TRAFFIC.

3. AS AGREED IN THE PREVIOUS EXCHANGES ON THE ACKERMANN  
VISIT, WE WOULD LIKE TO HAVE A FIRM AGENDA SO THAT BOTH SIDES WILL  
BE ABLE TO DISCUSS SPECIFICS RATHER THAN BROAD OPERATIONAL CONCEPTS.  
SUGGEST THAT YOU DISCUSS THE VISIT WITH HIM AT THE EARLIEST  
OPPORTUNITY SO THAT WE MAY PREPARE THE AGENDA AND TALKING  
POINTS.
