1. FOLLOWING FROM CASCOPE'S ALIAS ACKERMANN IN
RESPONSE TO REF.

2. ACKERMANN PLANS ARRIVE NYC AT 1535 HRS, 30 MAY 83,
VIA LH 408. HE WILL SPEND FOLLOWING DAY WITH CASCOPE
NYC OFFICE, TRAVELING ON TO WASHINGTON THAT EVENING. HE
WILL MAKE HIMSELF AVAILABLE FOR HQS DISCUSSIONS ON 1 AND 2
JUNE. HE PLANS TO DEPART WASHINGTON FOR FRG ON 3 JUNE.

3. IT IS ACKERMANN'S UNDERSTANDING THAT ABOVE
SCHEDULE HAS ALREADY BEEN DISCUSSED WITH PNEXCEL HQS BY
CASCOPE WASHINGTON REP. PLS CONFIRM.

4. ACKERMANN SAID (REPEATED) HE SUGGESTED
THE FOLLOWING DISCUSSION TOPICS:

A. POSSIBILITIES OF COOPERATION IN THE FIELD
OF "INDICATION AND WARNING"; (OF THE NEEDED INFORMATION,
WHICH PORTIONS MUST BE ACQUIRED BY HUMINT?);

B. POSSIBILITIES OF JOINT ACTIVITY IN THE FIELD
OF "EMBARGO/TECHNOLOGY TRANSFER."

C. POSSIBILITIES OF JOINT OPERATIONAL ACTIVITY,
ABOVE ALL:

- AGAINST THE SOVIETS IN THE HARBOR OF ANTWERP;
- AGAINST THE SOVIETS AND SATELLITES IN VIENNA;
- AGAINST TARGETS IN THE EAST SECTOR OF BERLIN.
