1. REFS B AND C BEING RELAYED FOR YOUR INFORMATION

2. ALTHOUGH THERE WAS DISCUSSION WITH ALIAS ACKERMANN OF TECHNOLOGY TRANSFER AND EARLY WARNING, THERE WAS NO MENTION OF THESE TOPICS IN CONNECTION WITH JOINT COOPERATION IN VIENNA. AS REF D POINTS OUT ONLY THE LHDEN TARGET WAS DISCUSSED AS A POSSIBLE AREA FOR COOPERATION.

3. REGARDING TECHNOLOGY TRANSFER, DURING THESE BRIEFINGS ACKERMANN NOTED THAT CASCOPE HAS RECEIVED PERMISSION TO PUT ONE OF THEIR MEN UNDER COVER WITH THE FRG PERMANENT DELEGATION TO IAEA. HE SUGGESTED THAT THIS COULD BE AN INTERESTING DEVELOPMENT AND A SOURCE OF LEADS IN THE TECH TRANSFER FIELD. WE AGREED BUT DID NOT MEAN TO AUTHORIZE HIS PURSUING POSSIBILITY OF "JOINT OPERATIONS" WITH []
